#### **Temperature controlled procedures**

#### **AEO FULL**

O&O Forwarding has received the "Authorized Economic Operator" certification.

This certification arises from the need to ensure the security of goods being imported, exported, and in transit.



It can be requested by any economic operator established in the EU who engages in activities related to customs operations and is granted to those deemed eligible after verification by the Customs Office.

#### Types of AEO certificates in the European Community:

There are three types of certifications valid for the European Community, in force since January 1, 2008, under Regulations (EC) No. 648/2005 and No. 1875/2006:

- AEOC (Customs) Customs simplifications;
- AEOS (Security) Security;
- AEOF (Full) Combined authorization of both previous certifications (customs simplifications plus security).

#### Criteria required to obtain AEO:

The criteria required to obtain AEO status are:

- · Compliance with customs regulations;
- An accounting and logistics system that allows for adequate customs security controls;
- Sound financial solvency;
- Adequate security standards.

The AEO certificate is a community-wide recognition that offers numerous advantages:

- Reliable and secure status with unlimited and community-wide validity;
- Facilitations on customs security controls and simplifications in the clearance process;
- Faster and more efficient transportation (in all phases);
- Cost reduction;
- Priority handling of cargo in case of selection for control;
- Better planning in the solutions offered to the client;
- Choice of the location for the control (this benefit is subject to agreement with customs);
- Reduction of theft and losses;
- Improved cooperation and communication among supply chain partners;
- Exemption from the provision of a guarantee for the introduction of goods into customs/ VAT warehouses;
- Customized control programs.



Our company's decision to apply for AEO certification is driven by the desire to offer our clients the best possible service-fast, efficient, and rigorous. The AEO (Authorized Economic Operator) qualification grants the status of "authorized economic operator" and today represents the highest recognition that the Customs Authority can grant to an international freight forwarder.
